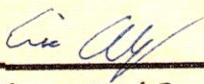
To All To Whom These Presents Shall Come:

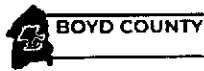

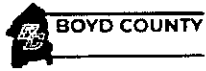

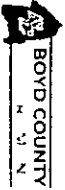

AN ORDINANCE RELATING TO THE INSTALLATION
OF SPEED HUMPS, THEIR CLASSIFICATIONS, THE REQUIREMENTS,
LOCATIONS, AND REMOVAL ON COUNTY OWNED ROADS

WHEREAS, Kentucky Revised Statute Section 189.337 is the controlling statute that requires the Transportation Cabinet, Department of Highways, to promulgate and adopt a manual of standards and specifications for a uniform system of traffic control devices for use upon all roads and streets in the state, including incorporated cities. The Kentucky Transportation Cabinet issued 603 Kentucky Administrative Regulation 5:050 Uniform Traffic Control Devices, which established the manual referenced by KRS 189.337, and states the standards and specifications set forth in the Federal Highway Administration (FHWA) Publication *Manual on Uniform Traffic Control Devices for Street and Highways (MUTCD)* shall apply to all traffic control devices installed on any publicly used highway, road or street in Kentucky.

NOW, THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF BOYD, COMMONWEALTH OF KENTUCKY:

Based upon the Federal Highway Administration MUTCD, speed humps are traffic calming devices that require motorists to reduce travel speeds as they drive over the device. Speed humps differ from speed bumps in that they are wider and shorter in height. The Institute of Transportation Engineers (ITE) published standards for construction, signage, and markings of speed humps in their recommended practice entitled *Guidelines for the Designs and Application of Speed Humps* and this was adopted by the Federal Highway Administration.

The following criteria will be reviewed before a Boyd County owned roadway is considered eligible for speed hump installation.

SECTION 1 ELGIBILITY REQUIREMENTS

Support: Although the Boyd County Road Department (BCRD) will utilize processes in order to determine if a segment of road is deemed appropriate for speed humps, generally the homeowners association or neighborhood representative(s) will be responsible for forwarding evidence of support for speed humps. The BCRD will not consider speed humps unless seventy (70) percent of the affected property owners favor their installation.

A petition will be provided by the Boyd County Fiscal Court (BCFC). Only one (1) vote per residential household is permissible. After a petition is filed, notice must be published, and signage posted in three (3) prominent and visible public places within one (1) mile of the roadway for thirty (30) days before the BCFC will take action.

Location of the Road: The land uses of the properties abutting the road where the speed hump is proposed shall be composed of low density residential dwellings. This would include public roadways where fifty percent (50%) or more of the residents are single family residential dwellings.

Operational Characteristics of the Road:

- a. The road shall be used to provide access to abutting low density residential properties. The road shall not be identified as a "Collector" or higher-level street. Speed humps shall not be considered on a street and/or road defined as Thru Streets.
- b. There shall be no more than one (1) moving lane of traffic in each direction.
- c. The road shall have a speed limit of twenty-five (25) mph, or less.
- d. The road shall not be so close to a Fire Department or other public safety facility, nor in the immediate proximity to a healthcare facility such as a nursing home, as to significantly interfere with emergency vehicle operations.
- e. If deemed necessary, the BCRD will also solicit comments from the appropriate Fire District, EMS, Police and appropriate service departments. If comments are

not received within two (2) weeks, BCRD will assume there are no objections. Should they identify significant concerns which cannot be corrected, BCRD will not install Speed Humps.

- f. Speed Humps shall not be considered on alleys.

Geometric Characteristics of the Road

- a. The road should have adequate sight distances to safely accommodate the hump. Sight Distance shall be available based on the speed limit of the roadway.
- b. The road shall not have curves or grades that prevent safe placement of the humps. Therefore, speed humps may be located on roads that contain curves and/or grades, but the hump itself should not be located within a significant horizontal curve, or a vertical grade greater than eight (8%) percent.
- c. The road must be paved. If there are no curbs, a special design of speed hump may be used to prevent vehicles from going around the speed hump.

SECTION 2 COST/MAINTENANCE RESPONSIBILITY

1. The cost for the speed hump materials shall be the responsibility of the Applicant (affected property owners/homeowners association) to purchase. This includes the cost of all speed hump material, warning signs, pavement markings, and, if necessary, special design features such as curbing. The type/style of speed hump ALLOWED to be used shall be coordinated with and approved by the BCRD.

2. The cost the initial installation of the speed hump shall be the responsibility of the BCRD. Only the BCRD (or a contractor hired by the BCRD) shall install the speed hump.

3. Roadways require routine maintenance (snow clearing, new pavement overlay, asphalt patching, etc). Should the speed hump be damaged during maintenance or need to be removed for such roadway maintenance, then the total cost for reinstallation (including labor costs and or new material costs) shall be the responsibility of the affected property owners and/or homeowners association. The homeowners association or residential representative will be notified on the cost to repair/replace the speed hump. If the homeowners association or residential representative are unwilling to pay for the cost of the speed hump repair/maintenance, the speed hump will be removed by the BCRD.

SECTION 3 SPEED HUMP REMOVAL AND ALTERATION

The process for speed hump removal or alteration by citizens is the same as the process for installation. Applicants may be required to assume 100% of the cost for alterations or removal of speed humps that were installed under this policy.

SECTION 4 SPEED HUMP LOCATION

The Boyd County Road Department will work with the property owners to the extent possible on the location of the speed hump. For engineering and/or safety reasons, the best location for a speed hump may be in front of a property where the property owner opposes it. BCRD will take those preferences into consideration, but BCRD will make the final decision on placement.

SECTION 5 DESIGN STANDARDS AND PROCEDURES

The Boyd County Road Department will prepare and maintain current design standards and installation procedures for speed humps according to these guidelines. The BCRD will provide minimum speed hump design standards allowed and types of speed humps available for purchase.

The design and installation of speed humps shall comply with the ITE's Recommended Practice. All signage and pavement markings shall comply with the current edition of the MUTCD and ITE's Recommended Practice, *Guidelines for Design and Application of Speed Humps*.

SECTION 6 PROCEDURES TO REQUEST SPEED HUMP INSTALLATION

1. The Applicant's initial request for the installation of speed jumps shall originate from a representative of the affected property owners or homeowners association from a segment of the street or neighborhood group. The request should be provided on the attached form and

forwarded to the following address: **Boyd County Road Department, Attn: County Road Foreman, 12327 Anthony Drive, Ashland, KY 41102.**

2. If the Applicant does not represent any existing homeowners association for the particular roadway or a homeowners association does not exist for the roadway, then a representative of the area shall submit written petitions (with Names, Addresses, Telephone Number, and Signatures) to BCRD showing that seventy (70) percent of the property owners on the street/road support the installation of speed humps.

3. BCRD will make a preliminary determination of eligibility. BCRD will coordinate with the Boyd County Fiscal Court for their review and approval. BCRD if deemed necessary, will conduct the necessary transportation engineering studies, including, but not limited to: traffic volume, accident analysis, speed study, field review, etc. BCRD will solicit comments and recommendations of other agencies, including, but not limited to, emergency service and appropriate service departments. A determination of the road's eligibility for speed hump installation will be made in writing, in a timely manner, to the applicant's representative, based on the speed hump guidelines.

- a. If the road is determined to be ineligible, the applicant's representative will be given written notification of that determination and its reasons.
- b. BCRD will define the petition area, define the proposed speed hump locations, and determine the total cost.
- c. Once a street is approved for speed hump installation, BCRD will submit a statement to the applicant's representative for the cost of the speed hump installation. The initial cost to the applicant shall be the cost of the speed hump material. Once payment is received, the BCRD will order materials. The BCRD shall be responsible to install the speed hump. Upon receipt of materials, the BCRD will install the speed humps as scheduling permits.

SECTION 7 DEFINITIONS

AFFECTED PROPERTY OWNERS - Includes only those properties adjacent to the right-of-way of the segment of the street where the Speed Humps are proposed or within a subdivision development which has an active Homeowners Association.

APPLICATIONS for SPEED HUMPS - Includes a petition by ballot of the affected property owners/and or Homeowners Association.

FUNCTIONAL CLASSIFICATION - The process by which streets and highways are grouped into classes or systems according to the character of service they are intended to provide. (*Highway Functional Classification and Needs Study Manual*).

Arterial System - provides for through traffic movement between areas and across the city, with limited access to abutting property, but subject to access controls and curb uses.

Collector System - provides for traffic movement between arterials and local streets, with limited access to abutting properties.

Local System - provides direct access to abutting properties.

LOW DENSITY RESIDENTIAL DWELLINGS - Includes single-family houses, townhouses, duplexes, triplexes and quadraplexes.

ROADWAYS - That portion of a highway improved, designed, or ordinarily used for vehicular travel, exclusive of the berm or shoulder. If a highway includes two (2) or more separate roadways, the term "roadway," as used herein, shall refer to any roadway separately, but not to all such roadways collectively.

SPEED HUMPS - Geometric design feature of a roadway, consisting of a raised area in the roadway pavement surface, extending transversely across the travel way, whose primary purpose is to reduce the speed of vehicles traveling along the roadway.

SECTION 8

The provision of this ordinance are severable and the invalidity of any provision of this ordinance shall not affect the validity of any other provision hereof; and such other provisions shall remain in full force and effect as long as they remain valid in the absence of those provisions determined to be invalid.

SECTION 9

This Ordinance shall be in full force and effect from and after its adoption and publication of a summary thereof as provided by law.

A RESOLUTION OF THE FISCAL COURT OF THE COUNTY OF BOYD, KENTUCKY (THE "COUNTY"), AUTHORIZING THE EXECUTION OF A MEMORANDUM OF AGREEMENT, AND AN AGREEMENT IN LIEU OF TAXES ATTACHED THERETO, BETWEEN THE COUNTY AND REVOLUTIONARY RACING KENTUCKY, LLC RELATING TO THE ACQUISITION, CONSTRUCTION, EQUIPPING AND INSTALLATION OF A RECREATIONAL PROJECT FOR A STATE-OF-THE-ART LIVE AND HISTORICAL RACING FACILITY, ALONG WITH RELATED AMENITIES (THE "PROJECT"); AGREEING TO UNDERTAKE THE ISSUANCE OF INDUSTRIAL BUILDING REVENUE BONDS AT THE APPROPRIATE TIME TO PAY THE COSTS OF ACQUIRING, CONSTRUCTING, EQUIPPING AND INSTALLING SAID PROJECT AND FACILITIES; AND TAKING OTHER PRELIMINARY ACTION.

WHEREAS, Revolutionary Racing Kentucky, LLC, a Delaware limited liability company authorized to do business in the Commonwealth of Kentucky, or its assigns, (the "Company"), proposes the acquisition, construction, equipping and installation of a recreation project to develop and operate a state-of-the-art live and historical racing facility, along with related amenities and uses (the "Project"), as provided for in Section 103.200(1)(e) of the Kentucky Revised Statutes, and in this respect, it has been determined that the County may assist the Company through the issuance of Bonds [as hereafter defined] for the acquisition, construction, equipping and installation of the Project and by entering into at the appropriate time a lease agreement with reference thereto pursuant to authority of Sections 103.200 to 103.285, inclusive, of the Kentucky Revised Statutes (collectively, the "Act"), all in furtherance of the purposes of the Act and the public benefit of the residents and inhabitants of the County; such lease agreement to be upon such terms and conditions as the Act may require and the County may deem advisable; and

WHEREAS, the acquisition, construction, equipping and installation of the Project by the Company will encourage the expansion of commerce in accordance with the public policy of the Commonwealth of Kentucky by promoting the economic development of the Commonwealth of Kentucky and the County, will relieve conditions of unemployment, will encourage the increase of commerce and will improve the economic welfare of the people of the County; and

WHEREAS, the County is further authorized by the Act to issue bonds, which term under the Act encompasses bonds, variable rate bonds, commercial paper bonds, bond anticipation notes or any other obligations for the payment of money issued by a County, county or other authority pursuant to the Act, for the purpose of defraying the cost of acquiring, constructing, equipping and installing an industrial building or buildings, as defined in the Act; discussions have occurred between representatives of the Company and the County incident to

the issuance of industrial building revenue bonds by the County; the County has agreed with the Company to issue such bonds upon compliance by the Company with certain conditions, requirements and obligations, and subject to the approval of the County of the terms of all agreements, ordinances and other documents required incident to said bond issue; and the County has authorized the Company to proceed with the acquisition, construction, equipping and installation of the Project, subject to reimbursement of the costs of the Project from the proceeds of such bonds, when, as and if issued; and

WHEREAS, based upon an estimate of the costs of the Project, the County proposes to issue its industrial building revenue bonds in one or more series as determined by the Company and agreed to by the County in an amount not to exceed Ninety Million Dollars (\$90,000,000) (the "Bonds"), such Bonds to be sold and delivered by the County to pay the costs of the Project, together with costs incident to the authorization, sale and issuance of such Bonds, but with such contributions from the Company as may be necessary; and

WHEREAS, the County proposes to enter into, a lease agreement with the Company with respect to the Project, whereby the Company will covenant and agree to pay amounts sufficient to provide for the payment of principal of and premium, if any, and interest on the Bonds, together with all trustee and paying agents' fees in connection with the Bonds as the same become due and payable; the liability of the Company under this instrument or any other instrument related to the issuance of the Bonds shall be limited to its interest in the Project to be financed thereby and no party shall have the right to obtain payment from the Company or from any assets of the Company other than such Project; and

WHEREAS, it is deemed necessary and advisable that a Memorandum of Agreement between the County and the Company be executed setting forth the preliminary agreements of the parties with respect to the acquisition, construction, equipping and installation of the Project, the issuance of the Bonds to defray the costs thereof and the payments to be made by the Company with respect to the Project; and

NOW, THEREFORE, BE IT ORDERED AND RESOLVED BY THE FISCAL COURT OF THE COUNTY OF BOYD, KENTUCKY, AS FOLLOWS:

Section 1. It is hereby found, determined and declared that (i) the recitals set forth in the preamble to this Resolution, which are incorporated in this Section by reference, are true and correct; (ii) the total amount of money necessary to be provided by the County for the acquisition, construction, equipping and installation of the Project to be financed by the Bonds will not exceed Ninety Million Dollars (\$90,000,000); (iii) the Company has represented that it will have sufficient financial resources to acquire, construct, equip and install the Project and to place it in operation and to continue to operate, maintain and insure the Project throughout the term of the Bond issue, meeting when due the obligations of the proposed lease agreement; and (iv) sufficient safeguards will be provided by the lease agreement to insure that all money provided by the County from the proceeds of the sale of the Bonds will be expended by way of direct expenditure or reimbursement, solely and only for the purposes of the Project.

Section 2. It is hereby found, determined and declared that the cost of acquiring, constructing, equipping and installing the Project will be paid out of the proceeds of the Bonds and such contributions of the Company as may be necessary to complete the Project as defined in the lease agreement to be executed by and between the County and the Company at the appropriate time pursuant to the Act; **THAT NONE OF THE BONDS WILL BE GENERAL OBLIGATIONS OF THE COUNTY; THAT NEITHER THE BONDS NOR THE INTEREST THEREON SHALL CONSTITUTE OR GIVE RISE TO ANY INDEBTEDNESS OF THE COUNTY OR ANY CHARGE AGAINST ITS GENERAL CREDIT OR TAXING POWER, BUT THAT THE BONDS AND THE PAYMENT OF INTEREST THEREON SHALL BE SECURED AND PAYABLE SOLELY AND ONLY BY A PLEDGE OF AMOUNTS TO BE PAID BY THE COMPANY UNDER SUCH LEASE AGREEMENT; AND THAT NO PART OF SAID COSTS WILL BE PAYABLE OUT OF ANY GENERAL FUNDS, REVENUES, ASSETS, PROPERTIES OR OTHER CONTRIBUTIONS OF THE COUNTY.**

Section 3. In order to induce the acquisition, construction, equipping and installation of the Project in the County with the resultant public benefits which will flow therefrom, it is deemed necessary and advisable that the Memorandum of Agreement hereinafter referred to be approved and executed for and on behalf of the County. Accordingly, the Memorandum of Agreement by and between the Company and the County substantially in the form and with the contents set forth in EXHIBIT A attached hereto and incorporated herein by reference is hereby approved and the County Judge/Executive is hereby authorized and directed to execute and deliver said Memorandum of Agreement.

Section 4. Inasmuch as the Project is to be acquired, constructed, equipped and installed in order to conform to the requirements of the Company, so that the Company may provide additional housing, economic development and employment to citizens and residents of the local community, and inasmuch as the Company is able to plan, acquire, construct, equip and install the Project and possesses more expertise in such matters, it is hereby found, determined and declared that acquisition, construction, equipping and installation of the Project should be undertaken or caused to be undertaken by the Company. Accordingly, the Company is hereby authorized to formulate and develop plans for the acquisition, construction, equipping and installation of the Project and to enter into such contracts and undertakings as may be required for the acquisition, construction, equipping and installation of the Project. Reimbursements made to the Company after the receipt of the proceeds of the sale of the proposed Bond issue by the County shall be subject to the certifications by qualified persons to be designated by the Company as specified in the lease agreement to be entered into by the County and the Company at the appropriate time pursuant to the Act.

Section 5. This Resolution and the Memorandum of Agreement approved hereby constitute the present official intent of the County to issue the Bonds in one or more series at a later date, with the understanding that issuance of the Bonds shall be contingent upon the execution of an Agreement In Lieu of Taxes satisfactory to the County, a copy of which is attached as Exhibit A to the Memorandum of Agreement.

Section 6. Keating Muething & Klekamp PLL, Cincinnati, Ohio, is hereby approved as local Bond Counsel. Local Bond Counsel is authorized and directed to take any legal action necessary or appropriate in connection with the issuance of the Bonds. The County Attorney is authorized and directed to assist Local Bond Counsel in any appropriate manner.

Section 7. No County funds shall be expended on the Project, except such as are derived from Bond proceeds.

Section 8. To the extent any resolution, ordinance or part thereof is in conflict, the provisions of this Resolution shall prevail and be given effect.

Section 9. This Resolution shall be in full force and effect from and after its adoption as provided by law.

MEMORANDUM OF AGREEMENT REGARDING ISSUANCE OF INDUSTRIAL BUILDING REVENUE BONDS

This MEMORANDUM OF AGREEMENT REGARDING ISSUANCE OF INDUSTRIAL BUILDING REVENUE BONDS, by and between the COUNTY OF BOYD, KENTUCKY (the "County") and REVOLUTIONARY RACING KENTUCKY, LLC, a Delaware limited liability company, or its assigns, to be authorized to do business in the Commonwealth of Kentucky (the "Company").

WITNESSETH:

1. Preliminary Statement. Among the facts and circumstances which have resulted in the execution of this Memorandum of Agreement by and between the parties are the following:

(a) The Company is desirous of acquiring, constructing, equipping and installing a recreation project involving a state-of-the-art live and historical racing facility, along with related amenities and uses in the County of Boyd, Kentucky (the "Project").

(b) The Project proposed to be acquired, constructed, equipped and installed for use by the Company will constitute an "industrial building" within the meaning of Section 103.200 of the Kentucky Revised Statutes.

(c) The Company is initiating the development of plans, specifications and designs for the Project and has entered into discussions with the County with respect to the financing thereof. The Company estimates that the aggregate cost of the Project will not exceed Ninety Million Dollars (\$90,000,000), including financing costs, which will be issued in one or more series of Bonds.

(d) The County is authorized and empowered by the provisions of Sections 103.200 to 103.285, inclusive, of the Kentucky Revised Statutes (collectively, the "Act") to issue bonds, which term under the Act encompasses bonds, notes, variable rate bonds, commercial paper bonds, bond anticipation notes or any other obligations for the payment of money issued by a County, county or other authority pursuant to the Act, for the purpose of defraying the costs of acquiring, constructing, equipping and installing an industrial building or buildings, as defined in the Act, in order to promote the economic development of the Commonwealth and the establishment, retention or expansion of industry. The County is empowered, with respect to such industrial building facilities so acquired, constructed, equipped and installed, to enter into at the appropriate time a lease agreement with a concern such as the Company providing for such payments by the Company and such other terms and conditions as the County may deem advisable.

(e) The purposes of the Act, inter alia, are to promote the economic development of the Commonwealth of Kentucky, to relieve conditions of unemployment, to

encourage the increase of industry in Kentucky, and to aid in the retention of existing industry by certain described means. In furtherance of such purposes the County, at the request of the Company, proposes to cause to be acquired, constructed, equipped and installed the Project for the Company's use in connection with the operations of the Company in the County. The County intends to finance the Project and to enter into at the appropriate time a lease agreement with the Company pursuant to the provisions of the Act with respect to the Project.

(f) The Company is ready, willing and able to cause initial acquisition, construction, equipping and installation of the Project to be undertaken, but has been advised by counsel that in order to warrant the issuance of industrial building revenue bonds by the County it is necessary that official action be taken by the County approving the Project and agreeing to issue at the appropriate time industrial building revenue bonds to finance the costs of acquisition, construction, equipping and installation of the Project.

(g) Representatives of the County have indicated the willingness of the County to proceed with and to carry out such industrial building revenue bond financing in order to effectuate the purposes of the Act and have advised the Company that, subject to due compliance with all requirements of law and the obtaining of all necessary consents and approvals required by law, and to the happening of all acts, conditions and things required precedent to such financing, including satisfaction of all requirements of the County, the County, by virtue of authority of the Act, will issue and sell its industrial building revenue bonds in one or more series as determined by the Company and agreed to by the County in an amount not to exceed Ninety Million Dollars (\$90,000,000) (the "Bonds").

(h) The County considers and determines that the acquisition, construction, equipping and installation of the Project, and the execution of a lease agreement with the Company at the appropriate time with reference to the Project, will promote and further the purposes of the Act.

(i) Pursuant to KRS 103.230(1), the Company has requested and hereby requests that the sale of the Bonds by the County be made upon a negotiated basis in a manner to be determined by the Company.

(j) That the County and Company acknowledge that the commitment of the County shall be conditioned upon the execution of an Agreement in Lieu of Taxes attached as Exhibit A.

2. Representations and Undertakings on the Part of the Company. The Company represents, undertakes, covenants and agrees as follows:

(a) That the Company intends to utilize the Project, or cause the Project to be utilized, at all times during the term of the lease agreement to be entered into at the appropriate time by and between the County and the Company with reference to the Project for the purposes hereinbefore indicated;

(b) That the Project will tend to increase economic development and relieve conditions of unemployment;

(c) That the Company will cause contracts to be entered into for, or will otherwise provide for, the acquisition, construction, equipping and installation of the Project;

(d) That prior to or contemporaneously with the delivery of the Bonds the Company will enter into a lease agreement with the County under the terms of which the Company will obligate itself to undertake and to complete the acquisition, construction, equipping and installation of the Project and to pay to the County sums sufficient in the aggregate to pay the principal of, interest on, and premium, if any, on the Bonds as and when the Bonds shall become due and payable, such lease agreement to contain such other provisions as shall be agreed upon by the County and the Company; and

(e) The Company will take such further action and adopt such further proceedings as may be required to implement its aforesaid undertakings or as it or the County may deem appropriate in pursuance thereof.

3. Undertaking on the Part of the County. Subject to the fulfillment of the several conditions herein stated, the County agrees as follows:

(a) That it will at the appropriate time authorize or cause to be authorized the issuance and sale of the Bonds pursuant to the terms of the Act as then in force in an aggregate principal amount not to exceed Ninety Million Dollars (\$90,000,000), or such other aggregate principal amount as shall be sufficient to pay the costs of the Project and related costs when actually determined;

(b) That it will adopt or cause to be adopted such proceedings and authorize the execution of such documents as may be necessary or acceptable for (i) the authorization, issuance and sale of the Bonds, (ii) the acquisition, construction, equipping and installation of the Project, (iii) providing for the payment of principal of and interest on the Bonds by the lease agreement with the Company pursuant to the Act, all as shall be authorized by the Act and upon terms which shall be mutually satisfactory to the County and the Company;

(c) That the aggregate basic payments stipulated to be made by the Company under the lease agreement with the County with reference to the Project shall be at least sufficient (in addition to covenants of the Company to properly operate, maintain and insure the Project) to pay the principal of, interest on and redemption premium, if any, on all of the Bonds as and when the same become due and payable, whether at maturity or prior redemption or upon any acceleration of payment of principal as provided in the Bond proceedings; and

(d) That it will take or cause to be taken such other acts and adopt such further proceedings as may be required to implement the aforesaid undertakings as it may deem appropriate.

4. General Provisions.

(a) The Company has requested that the sale of the Bonds be negotiated in the manner permitted by statute and that the terms of the sale be subject to approval by the Company.

(b) All commitments of the County and the Company pursuant to this Memorandum of Agreement are subject to the condition that on or before one year from the date hereof or such later date as shall be agreed upon by the County and the Company, the County and the Company shall have agreed to mutually acceptable terms and conditions with respect to the lease agreement referred to in this Memorandum of Agreement and the details of the industrial building revenue bond financing.

(c) If the event set forth in (b) of this paragraph does not take place within the time set forth therein, or any agreed extension thereof, and the Bonds are not issued within such time, the Company agrees that it will reimburse the County for all reasonable and necessary direct out-of-pocket expenses which the County may incur at the Company's request arising from the execution of this Agreement, and the performance by the County of its obligations hereunder shall thereupon terminate.

(d) This Memorandum of Agreement and the Resolution approving this Memorandum of Agreement constitute the present official intent of the County to issue the Bonds at a later date.

(e) **NONE OF THE BONDS WILL BE GENERAL OBLIGATIONS OF THE COUNTY AND NEITHER THE BONDS NOR THE INTEREST THEREON SHALL CONSTITUTE OR GIVE RISE TO ANY INDEBTEDNESS OF THE COUNTY OR ANY CHARGE AGAINST ITS GENERAL CREDIT OR TAXING POWER. THE BONDS AND THE PAYMENT OF INTEREST THEREON SHALL BE SECURED AND PAYABLE SOLELY AND ONLY BY A PLEDGE OF AMOUNTS TO BE PAID BY THE COMPANY UNDER ANY LEASE AGREEMENT WITH THE COUNTY AS REQUIRED BY THE ACT. NO PART OF THE COSTS OF ACQUIRING, CONSTRUCTING, EQUIPPING AND INSTALLING THE PROJECT WILL BE PAYABLE OUT OF ANY GENERAL FUNDS, REVENUES, ASSETS, PROPERTIES OR OTHER CONTRIBUTIONS OF THE COUNTY.**

AGREEMENT IN LIEU OF TAXES

This Agreement In Lieu of Taxes (this "Agreement") is made effective as of the ____ day of _____, 2023, by and among the County of Boyd, Kentucky (the "County") and Revolutionary Racing Kentucky, LLC a Delaware limited liability company, and its successors, assigns and/or transferees (the "Developer"); (the aforementioned are together referred to as the "Parties");

WITNESSETH

WHEREAS, the Developer has or will acquire property in the County of Boyd, Kentucky, located at or adjacent to the former KYOVA Mall (as more particularly described in Exhibit A hereto, collectively, the "Property"), and plans to develop the Property as a recreational facility featuring live and historical racing and related complementary uses, together with related site amenities (the "Project"); and

WHEREAS, the County has agreed to (i) issue Industrial Building Revenue Bonds (the "Bonds") to finance the acquisition, construction and equipping of the Project, (ii) accept title to the Property and enter into a Lease Agreement with the Developer for the Property (the "Lease Agreement"), and (iii) in conjunction with the foregoing, enter into this Agreement to memorialize the Developer's obligation to make payments in lieu of taxes ("PILOT Payments") with respect to the Property to the County, and other local taxing districts in the County of Boyd, Kentucky, that have taxing jurisdiction over the Property (the "Local Taxing Districts") in the amounts set forth herein; and

WHEREAS, the Developer and the County will enter into an Inducement Contract, wherein the County agrees to authorize, issue, and sell the Bonds in an amount specified

therein, pursuant to KRS 103.200 through 103.285, to finance the acquisition, construction and equipping of the Project; and

WHEREAS, the Bonds will be issued, subject to the terms of a Trust Indenture executed at the time of the issuance and delivery of the Bonds (the "Trust Indenture") which Trust Indenture shall appoint a trustee (the "Trustee") for the administration thereof; and

WHEREAS, the economic incentive to the Developer, by virtue of the issuance of the Bonds and the execution of the Lease Agreement, is the abatement of real and tangible property *ad valorem* taxes with respect to the Property; and

WHEREAS, it is understood by the Parties that the Boyd County Property Valuation Administrator (the "PVA") is responsible for establishing assessed value of real property within Boyd County, Kentucky, for the purpose of imposing real property *ad valorem* taxes; and

NOW, THEREFORE, in consideration of the premises and mutual covenants hereinafter contained, the Parties hereto agree as follows:

1. Recitals. The Parties hereafter confirm and affirm the accuracy of the Recitals contained above and those contained herein.

2. Valuation of Property. That the valuation of the Property shall be the fair cash value for the Property as determined by the PVA, which shall be set and adjusted in accordance with the PVA's standard practices as the Project is developed. The tax rates for use in calculating PILOT Payments for the term of this Agreement will be the actual real property *ad valorem* tax rates for the County, the Health District, the Library District, the Ambulance District and the Extension District (collectively the "Local Taxing Districts")

and the Boyd County School District (the "School District") in effect for each respective year the Bonds are outstanding. It is understood that the valuation of the Property may change over time as determined by the PVA.

3. Commencement of Obligations. The obligation to make PILOT Payments will commence on November 30th the year after the date the Bonds are issued, and shall be due each by December 31st each year thereafter during the term of the Bonds, and shall be the obligation of the Developer.

4. Issuance of Bonds/Tax Abatement. Upon the issuance of the Bonds, the transfer of the Property and the execution of the Lease Agreement, the Property will be exempt from local real property *ad valorem* taxes pursuant to the provisions of Section 103.285 of the Kentucky Revised Statutes, but shall be subject to the PILOT Payments as set forth in this Agreement. The term of the exemption from real property *ad valorem* taxes with respect to the Property shall be the earlier of (i) the termination of the Lease Agreement, (ii) thirty (30) years from the date the Bonds are issued, or (iii) the date the Bonds are fully paid or defeased (the "Exemption Termination Date").

5. Obligation to Make PILOT Payments. During the term of the Bonds the Developer shall make the following PILOT Payments:

- a. The Developer shall make annual PILOT Payments to the County, based on a pilot tax bill prepared by the County, in an amount equal to fifty percent (50%) of the amount the Local Taxing Districts would have received from the Property based on the value of the Property as determined by the PVA over \$15,000,000, but for the issuance of the Bonds, based on their respective real property *ad valorem* tax rates; plus an amount equal to one

hundred percent (100%) of the amount the Local Taxing Districts would have received based on a taxable value of \$15,000,000. Following the receipt of payment of the of the Pilot Payments from the Developer, the County shall within thirty (30) days of receipt distribute the Pilot Payments to the respective Local Taxing Districts, based on their respective share of the Pilot Payments in proportion to their respective tax rates.

- b. The Developer shall make annual PILOT Payments to the School District, based on a pilot tax bill prepared by the School District, in an amount equal one hundred percent (100%) of the amount the School District would have received based on the value of the Property as determined by the PVA, but for the issuance of the Bonds.

6. Real Property *Ad Valorem* Taxes After Bonds Mature. Upon the Exemption Termination Date, the County shall convey the Property to the Developer (or its assignees or transferees), and the real property *ad valorem* tax exemption shall cease, and the Local Taxing Districts, shall receive one hundred (100%) of the real property *ad valorem* taxes with respect to the Property at the tax rates established each year in accordance with the assessment for the Property as determined by the PVA.

7. Other Taxes. Other than the real property and tangible *ad valorem* taxes discussed herein, this Agreement does not affect or apply to any other taxes or fees that may be owed by the Developer (or its assignees or transferees) to the Local Taxing Districts and the School District. The Developer acknowledges that this Agreement will not be inconsistent with or will not conflict with any bond placement agreement, any financing agreement, the Trust Indenture, or the Lease Agreement executed or to be

executed in connection with the Bonds (collectively, the "Bond Documents"), and to the extent that this Agreement is inconsistent or in conflict with the Bond Documents, the terms and language of this Agreement shall control over the Bond Documents.

8. Term of Bonds. It is further understood by the Parties that the final maturity date of the Bonds shall not exceed thirty (30) years from their date of issuance.

9. Notices.

10. Modification and Assignment. This Agreement may not be changed orally, but only by an agreement in writing executed by the Parties. So long as the Developer is not in default with any provisions of this Agreement, the Bond Documents or other agreements with the County, the Developer may assign its rights and obligations under this Agreement to a lender that may provide financing for the Project, to an entity controlled by the Developer that may be formed to undertake all or part of the Project, or with consent of the County to a third-party purchaser of the Property.

11. Effect of Bankruptcy. In the event that the Developer, its assigns or transferees shall file a voluntary action seeking relief under applicable bankruptcy laws,

or have an involuntary action filed against it seeking such relief, then and in that event, it is agreed that all payments required by this Agreement shall be treated the same as if they were *ad valorem* taxes under applicable Kentucky law, giving said payments and obligations preference over all other secured and unsecured creditors.

12. Delinquent Payments. PILOT Payments not paid when due shall be subject to interest and penalty to the same extent as regular real property *ad valorem* taxes to the County.

13. Legally Binding. This Agreement is legally binding upon the County and the Developer and its assigns and transferees.

14. Governing Law and Jurisdiction. The Parties agree that this Agreement is governed by the laws of the Commonwealth of Kentucky. Any action taken by the Parties or Trustee to enforce or seek relief from the terms and conditions of this Agreement shall be brought in Boyd Circuit Court.

15. Entire Agreement. This Agreement contains the entire agreement of the Parties hereto in respect to the transaction contemplated hereby and all prior agreements, whether oral or written, are superseded hereby.


16. Severability. Wherever possible, each provision of this Agreement shall be interpreted in such manner as to be effective and valid, but if any provision herein shall be deemed to be invalid such provision shall be ineffective to the extent of such invalidity without invalidating the remainder of the provisions contained in this Agreement.

17. Authorization. The Parties hereto represent that each is duly authorized and empowered to enter into this Agreement.

18. Counterparts. This Agreement may be executed in any number of duplicate originals and each duplicate original shall be deemed to be an original.

Grant Administrative Service Contract

This agreement for administrative services (this 'agreement') is made effective as of the date of signing, by and between Fiscal Court of Boyd County, KY and Northeast Kentucky Grant Management, LLC, of 1109 W New Buckley Rd, Ashland, KY 41102. Hereafter referred to as "Grantee" and "Grant Administrator".

In consideration of the mutual promises set forth below, the parties agree as follows:

Description of Services

Beginning on the date of signing, Grant Administrator will provide grant management and administrative services as described below as necessary for the award and payment of the AML Pilot Program Grant, the memorandum of agreement of which was executed by the grantee on 12/15/2022:

- Advise on and assist in completing all documents necessary for grant award
- Provide updates, in-person or virtual, as needed with staff or officials of grantee
- Complete all updates, reports, or other documentation as required by the funding agency to maintain compliance with the above-mentioned Memorandum of Agreement
- Conduct monthly meetings with all involved parties as required by above-mentioned Memorandum of Agreement
- Complete pay requests promptly and submit for reimbursement by funding agency
- Submit final closeout paperwork once project has been confirmed completed by grantee and engineering firm

Grantee Obligations

Grantee agree that they will take all necessary steps as reasonably required to allow grant administrator to complete the above tasks. These include but may not be limited to the following:

- Designate an agency contact responsible for the day to contact and completion of grantee obligations
- Provide all documentation required as referenced in the above-mentioned Memorandum of Agreement necessary for the administration of this grant and for submitting draw requests as needed
- Provide invoices to grant administrator prior to payment for validation
- Take such further steps to execute documents as needed

In addition to the above services and obligations, both parties will take any additional and reasonable actions to resolve any issues arising during the course of this contract.

Grantee Fees:

In consideration of the service to be provided by the Grant Administrator, Grantee agrees to compensate the Grant Administrator for the services rendered in the amount allocated to Administrative Services in the attached budget less an initial amount to be determined by Kentucky Division of Abandoned Mine Lands paid to the prior administrative agency for services rendered.

The remainder of these funds will be paid to Northeast Kentucky Grant Management using the provisions set forth by Kentucky Division of Abandoned Mine Lands pursuant to the Memorandum of Agreement with that agency. The total

amount billed by both administrative agencies not to exceed the total amount allocated for Administrative Services in that document.

Payments for administrative service will be paid on a schedule using guidelines set forth for AML projects determined by Boyd County Fiscal Court and Kentucky Division of Abandoned Mine Lands.

Grant Administrator agrees to include all fees associated with administration of this project into the awarded grant and to be paid in full from the grant amount awarded to the grantee.

Services outside of those above may be carried out as an addendum to this contract approved by both parties. Such services may require additional fees approved upon signing of any addendum to this contract.

Payment will be due in full within 30 days of completion of project and submission of final pay request to funding agency.

Termination

This agreement will terminate upon closeout of project by funding agency and final payment to the grant administrator.

Either party may voluntarily terminate this contract at a prior time with written notification to the other party. At this point all grant documents will be turned over to the grantee and pro-rated payment based on percentage of project complete will be invoiced to the grantee. Grantee will be expected to pay that invoice within 30 days.

Relationship of Parties

It is understood by both parties that NEK Grant Management is an independent contractor with respect to the grantee and not an employee of the grantee. The grantee will not be responsible in paying any fringe benefits, including health benefits, vacation, or any other employee benefit for any staff of NEK Grant Management.

Product Ownership

Any documents, maps, materials, or other work created or modified as a part of this contact, in whole or in part, by NEK Grant Management in connection with the service provided shall be the exclusive property of the grantee. All documents will be turned over to the grantee upon their request or at the end of this contact. NEK Grant Management shall sign all documents necessary to confirm or perfect the exclusive ownership of these documents to the Grantee.

Confidentiality

NEK Grant Management will not, at any time or in any manner, either directly or indirectly, use for personal benefit of NEK Grant Management, divulge, disclose, or communicate in any manner any information that is proprietary to the grantee excepting correspondence made as a part of the grant management service to the funding agency or an agency affiliated with the funding agency as a part of this service or to engineers or other contactors connected to the grantee who may have legitimate need for such information. NEK Grant Management will protect such information and treat it as strictly confidential.

This provision shall continue to be effective after the termination of this contract. Upon termination of this contract, NEK Grant Management will return to grantee all records, notes, documentation, and other items that were used, created, or controlled by NEK Grant Management during the term of this contact.

Entire Agreement

This contract represents the entire agreement between NEK Grant Management and the grantee. There are no other promises or conditions in any other agreement whether oral or written. Addendums to this agreement may occur only upon the signed commitment of both parties. Such addendums will be added to this agreement in whole and will become part of the entire agreement.

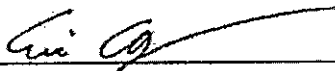
Severability

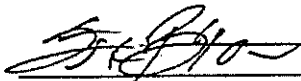

**AGREEMENT BETWEEN
COMMONWEALTH OF KENTUCKY
TRANSPORTATION CABINET
DEPARTMENT OF HIGHWAYS
AND
BOYD COUNTY**

THIS AGREEMENT, entered into by and between the Commonwealth of Kentucky, Transportation Cabinet, Department of Highways, hereinafter referred to as the “**Department**,” and Boyd County, 2800 Louisa Street, Catlettsburg, KY 41129, hereinafter referred to as the Local Public Agency (“**LPA**”).

WITNESSETH:

WHEREAS, the parties hereto desire to resurface Daniels Fork Road in Boyd County, which shall hereinafter be referred to as the “**Project**;”

WHEREAS, the **LPA** desires to be the lead agency and perform this **Project** to enhance the safety and reliability of roadway connections for the commuting public;

WHEREAS, the **LPA** shall refer to the applicable state requirements listed in the Project Development Guide for Local Public Agencies and any future revisions for assistance in complying with this Agreement;

WHEREAS, the **LPA** has asked the **Department** for funding assistance for costs incurred during this **Project**;

WHEREAS, the **Department** agrees this is a worthwhile **Project** and is willing to reimburse the **LPA** up to \$436,794 in state contingency funding (FD39) for the completion of this **Project**; and

WHEREAS, any cost in excess of the reimbursement funding (\$436,794) for this **Project** will be the responsibility of the **LPA**.

NOW, THEREFORE, in consideration of these premises and the mutual covenants contained herein, the parties hereby agree as follows:

1. The **Department** agrees to reimburse the **LPA** up to \$436,794 for completion of work by the **LPA**, or consultants, contractors, or subcontractors hired by the **LPA**, under the obligations of this Agreement for resurfacing Daniels Fork Road (CR 1320) from Milepoint 0.00 extending northerly to Milepoint 3.313 and 1.094 miles of Daniels Fork Road (CR 1159) which extends into Greenup County for approximately 4.407 miles.

This **Project** is designed to enhance the reliability of the highway network and safety for motorists in the area providing safe connections. Any ineligible costs or costs in excess of \$436,794 are the responsibility of the **LPA**. The **LPA** further agrees that they will require, in perpetuity, the placement of a culvert or road tile, for any new entrance constructed, that effects the drainage area, surrounding any of the roads listed in this agreement. The manner as to the implementation of this requirement, shall be at the discretion of the **LPA**.

2. The **Department** has authorized up to \$436,794 in state contingency funding (FD39) for all eligible expenses for this **Project**. This funding shall be made available for reimbursement to the **LPA** for all eligible expenses to the **Project**. The **LPA** shall be responsible for all eligible costs above the \$436,794 as well as any costs deemed ineligible for reimbursement from this **Project**. Any additional funding obligated for the completion of this **Project** shall be evidenced in writing by both parties with a Supplemental Agreement.
3. This Agreement is contingent upon the continued availability of appropriated funding. If the funding appropriated for the **Project** becomes unavailable for any reason including: the Kentucky General Assembly's failure to appropriate the funding, by operation of law or as the

result of a reduction in funding, further reimbursement of **Project** expenditures may be denied, the **Project** may be cancelled, the timeline extended or the scope amended by the **Department** either in whole or in part without penalty. Denial of further reimbursement, **Project** cancellation, extension or amendment because of an interruption in the appropriated funding is not a default or breach of this Agreement by the **Department** nor may such denial, cancellation, extension or amendment give rise to any claim against the **Department**.

4. The effective date of this Agreement is the date of signature by the Secretary of the Transportation Cabinet. The Term of Eligible Reimbursement under this Agreement shall be three (3) years from the date of its execution unless extended or amended by written Agreement in accordance with the provisions of KRS 45A. Any and all funding obligated for any phase of this **Project** shall be available to reimburse the **LPA** for eligible work activities completed and costs incurred prior to expiration.
5. The **LPA** shall follow state specifications for each necessary phase of this **Project**. The **LPA** shall adhere to all state regulations, including KRS 45A, KRS 176, KRS 177, and all terms of this Agreement for activities related to this **Project** as lead agency. The **LPA** will obtain any required permits, licenses or easements required to initiate, perform, and complete work and provide documentation to the **Department's** District 9 Office in Flemingsburg. In addition, the **LPA** is responsible to meet all other requirements and adhere to all regulations necessary to qualify for the receipt of these state funds. Concurrence must be obtained by the **LPA** through the **Department's** District 9 Chief District Engineer in Flemingsburg prior to the awarding of any contract for work or materials to be used on this **Project**.
6. Should the **Project** require any design services, the **LPA** agrees to use only licensed consultants who are pre-qualified to do work for the **Department** or to use a licensed Professional Engineer registered in the Commonwealth of Kentucky that demonstrates sufficient experience and knowledge in the type of work and receives the approval of the **Department's** District 9 Chief District Engineer in Flemingsburg. The **LPA** shall be

responsible for all **Project** design activities, which may be completed either by the **LPA's** staff or a consultant that is to be selected based on qualifications. All design work to be contracted must comply with all legal advertisement and selection requirements including, but not limited to, the Model Procurement Code provisions of KRS 45A and KRS 424. The **LPA** shall submit and obtain concurrences to the **Department's** District 9 Chief District Engineer in Flemingsburg final design plans, specifications, and a total estimate prior to any construction. When applicable, the **LPA** must obtain any necessary permits or easements to allow for work to be accomplished on this **Project** and adhere to the Uniform Relocation Assistance (URA) and Real Property Acquisitions Policies Act.

7. Should the **Project** require the acquisition of any interest in real property by the **LPA**, the **LPA** shall ensure that all real property acquisition, relocation assistance, and property management are completed in a fair, equitable and approved manner consistent with all state laws and regulations governing the acquisition of real property for public use using highway funding. In all real property acquisitions, concurrence must be obtained through the **Department's** Division of Right of Way and Utilities and shall be subject to review and approval by the **Department**.
8. The **LPA** must obtain encroachment permits to allow for work to be accomplished on state owned right-of-way from the **Department's** District 9 Office in Flemingsburg. The **LPA** acknowledges that the **Department** will require the placement of a restrictive easement approved by and in favor of the **Department** in the chain of title of any real property acquired or improved pursuant to the **Project**. If the owner of any real property acquired or improved pursuant to the **Project** is not the **Department** or the **LPA**, the owner shall sign and be made a party to this Agreement and the owner hereby acknowledges, covenants and consents to the placement of a restrictive easement for perpetual maintenance of the property acquired or improved pursuant to the **Project** in the chain of title in favor of the **Department** prior to final reimbursement by the **Department**.

9. The **LPA** shall either adopt in writing the **Department's** written Policies and Procedures for Right of Way Acquisition and Relocation Assistance or present its own written Policies and Procedures for approval by the **Department's** Division of Right of Way and Utilities. The **LPA** shall conduct all appraisals and appraisal reviews using personnel meeting the **Department's** minimum qualifications and listed on the **Department's** pre-qualified appraiser and reviewer list. If the **LPA** chooses to use an acquisition consultant on all or any portion of the **Project**, the selection of the consultant shall be in accordance with the **Department's** Division of Right of Way Guidance Manual. All appraisals must be reviewed and approved by the **Department's** Central Office review appraisers, failure to do so will result in the **Project** being ineligible for funding reimbursement. The **LPA** shall provide property management in accordance with approved procedures and be responsible for the abatement of any asbestos containing materials and removal of contaminated soils pursuant to applicable state laws and regulations. The **LPA** shall provide the **Department** necessary assurance that all real property has been acquired and all displaced individuals, businesses, non-profit organizations and farms have been offered relocation assistance according to applicable state laws and regulations. The **LPA** shall provide the **Department** necessary documentation for review and approval at various stages of the acquisition process, as described in the **Department's** Right of Way Guidance Manual.
10. When conducting a utility relocation, KRS 177.035 and KRS 179.265 determine the necessity of payment for utility companies. Identification of utility or railroad facilities in conflict with the **Project**, the execution of a remedy for said conflict and oversight of the execution, and all work related to the **Project** shall be done in accordance with the Cabinet's Standards, Specifications, Standard Drawings, and Utilities and Rails Manual. Utility relocations shall be designed by the utility company and shown on the **Project's** survey and general plan sheets. The impacted utility company, with its regular construction or maintenance personnel, and/or with an approved contractor or subcontractor, will furnish all engineering, administration, labor, and materials to make and complete all necessary adjustments of its facilities to accommodate the **Project**. Correspondence pertaining to utility or railroad coordination must

be provided to both contracted parties. If a conflict of interest arises between the obligated party and a utility company, the unobligated party shall intercede to provide the utility coordination. The completed relocation shall be inspected to document the proper installation of the facilities. Upon full execution of the utility relocation for the **Project**, three (3) sets of as-built plans for each utility company that completes facility relocation on the project prior to the construction letting, a utility impact note defining the utilities identified in the **Project**, relocations that have been performed, incomplete relocations, and completion schedules for the incomplete work must be provided.

11. State construction criteria for the type of work shall be followed, including but not limited to the **Department's** Highway Design Manual, the **Department's** Standard Drawings, the **Department's** Standard Specifications for Road and Bridge Construction, the **Department's** Drainage Manual, the **Department's** Structural Design Manual, the American Association of State Highway Transportation Officials' (AASHTO) "Policy on Geometric Design of Highways and Streets," and the FHWA Manual on Uniform Traffic Control Devices (MUTCD). All work performed shall be in accordance with the **Department's** Standard Specifications for Road and Bridge Construction, edition of 2019, and as provided in Subsection 105.01 of said Specifications. All materials furnished shall be in accordance with Subsection 106 of said Specifications to include all **Department** List of Approved Materials. These standards, specifications, and criteria are incorporated in this Agreement by this reference.
12. The **LPA** agrees to use only licensed contractors and subcontractors who are pre-qualified to do work for the **Department** for any necessary construction services. The **LPA** shall be responsible for all **Project** construction activities, which may be completed either by the **LPA's** staff or through the advertisement, opening of bids, selection, and contracting for contractor services in accordance with the Model Procurement Code provisions of KRS 45A and KRS 424. Specific requirements defined within KRS 45A require that the award be made to the lowest responsive bidder meeting the criteria of responsibility established by the

Department. The contractor affirms that it is properly authorized under the laws of the Commonwealth of Kentucky to conduct business in this state and will remain in good standing to do business in the Commonwealth of Kentucky for the duration of any contract awarded. The contractor shall maintain certification of authority to conduct business in the Commonwealth of Kentucky during the term of this contract. Such registration is obtained from the Secretary of State, who will also provide the certification thereof. The LPA must receive **Department** approval for all change orders and shall have approval of the appropriate governing authority, but shall not increase the funding obligated to the LPA as a result of this Agreement.

13. Discrimination (because of race, religion, color, national origin, sex, sexual orientation, gender identity, age, or disability) is prohibited. During the performance of this contract, the LPA agrees as follows:
 - a. The LPA will not discriminate against any employee or applicant for employment because of race, religion, color, national origin, sex, sexual orientation, gender identity, or age. The LPA further agrees to comply with the provisions of the Americans with Disabilities Act (ADA), Public Law 101-336, and applicable federal regulations relating thereto prohibiting discrimination against otherwise qualified disabled individuals under any program or activity. The LPA agrees to provide, upon request, needed reasonable accommodations. The LPA will take affirmative action to ensure that applicants are employed and that employees are treated during employment without regard to their race, religion, color, national origin, sex, sexual orientation, gender identity, age or disability. Such action shall include, but not be limited to the following; employment, upgrading, demotion or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensations; and selection for training, including apprenticeship. The LPA agrees to post in conspicuous places, available to employees and applicants for employment, notices setting forth the provisions of this non-discrimination clause.
 - b. The LPA will, in all solicitations or advertisements for employees placed by or on behalf of the LPA; state that all qualified applicants will receive consideration for employment

without regard to race, religion, color, national origin, sex, sexual orientation, gender identity, age or disability.

c. The **LPA** will send to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding, a notice advising the said labor union or workers' representative of the **LPA's** commitments under this section, and shall post copies of the notice in conspicuous places available to employees and applicants for employment. The **LPA** will take such action with respect to any subcontract or purchase order as the administering agency may direct as a means of enforcing such provisions, including sanctions for noncompliance.

d. The **LPA** will comply with all provisions of Executive Order No. 11246 of September 24, 1965 as amended, and of the rules, regulations and relevant orders of the Secretary of Labor.

e. The **LPA** will furnish all information and reports required by Executive Order No. 11246 of September 24, 1965, as amended, and by the rules, regulations and orders of the Secretary of Labor, or pursuant thereto, and will permit access to his books, records and accounts by the administering agency and the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations and orders.

f. In the event of the **LPA's** noncompliance with the nondiscrimination clauses of this contract or with any of the said rules, regulations or orders, this contract may be cancelled, terminated or suspended in whole or in part and the **LPA** may be declared ineligible for further government contracts or federally-assisted construction contracts in accordance with procedures authorized in Executive Order No. 11246 of September 24, 1965, as amended, and such other sanctions may be imposed and remedies invoked as provided in or as otherwise provided by law.

g. The **LPA** will include the provisions of paragraphs (1) through (7) of section 202 of Executive Order 11246 in every subcontract or purchase order unless exempted by rules, regulations or orders of the Secretary of Labor, issued pursuant to section 204 of Executive Order No. 11246 of September 24, 1965, as amended, so that such provisions will be binding upon each sub-contractor or vendor. The **LPA** will take such action with respect to any

subcontract or purchase order as the administering agency may direct as a means of enforcing such provisions including sanctions for noncompliance.

14. The **LPA** shall be responsible for all aspects of administration, measuring, testing, and inspections to ensure the materials and work meets the **Department's** specifications of the construction contract. This includes providing daily, on-site inspection of the contractor's work activities and processing all of the paper work associated with the construction contract, including any change orders. The **Department** shall have access to the **Project** area and may conduct field reviews of the **Project** at any time. These field reviews are intended to verify status of the **Project**, performance of the contractor, adequacy of the **LPA** oversight, conformance with all laws, regulations, and policies and provide assistance to the **LPA** as may be necessary.
15. The **LPA** may submit to the **Department's** District 9 Office in Flemingsburg current billings reflecting the actual cost of work incurred during any given work period, which will be paid within a reasonable time after receipt by the **Department**; however, in no event is the **LPA** to submit billings for work performed for less than a thirty (30) day period. All charges to the **Project** shall be supported by properly executed invoices, contracts, or vouchers evidencing in proper detail the nature and propriety of the charge. The **Department** may require additional documentation at their discretion.
16. The **LPA** is responsible for ensuring that all **Project** construction activities have been completed and are responsible for providing all of the necessary paperwork as required by the construction contract. The **LPA** will conduct a field inspection to verify completion of the work in conformance with the Agreement. This documentation must be provided to the **Department's** District 9 Chief District Engineer in Flemingsburg prior to final payment of the **Project**. When both the **LPA** and the **Department** accept the field work as complete, the **LPA's** project manager shall certify the **Project** was constructed in accordance with the plans and specifications and that all funding authorized on this **Project** has been used to reimburse

for materials, equipment, or labor as intended and at the location agreed herein by both parties. Upon receipt of the **Department's** Final Acceptance Report, the **LPA** will issue the final payment to the contractor with an official Release of Contractor form for signature. Within 30 days, the **LPA** shall provide the **Department** with a copy of the official Release of Contractor form, as well as proof of payment, which includes cancelled checks.

17. This Agreement and the maintenance responsibilities herein shall survive in perpetuity the cancellation or termination of all or any portion of the **Project**, and shall survive the completion of and acceptance of the **Project**. To protect the public interest and maintain the original intent, the **LPA** agrees to maintain in an acceptable condition all facilities improved by the **Project** to the condition existing at the time of the Final Acceptance Report in perpetuity. In the event that the **Project** improvements are not maintained as a public facility, the **LPA** shall reimburse the **Department** for all costs incurred and for all funding expended pursuant to the **Project**, including any applicable interest.
18. The **LPA** shall maintain for a period of three (3) years all records of materials, equipment, and labor costs involved in the performance of work of said **Project**. In order to obtain reimbursement from the **Department** for constructing said **Project**, the **LPA** shall submit to the **Department's** District 9 Office in Flemingsburg documented invoices of materials, equipment, and labor used on the **Project**, including certification that the work was accomplished on a publicly maintained facility.
19. No member, officer, or employee of the **Department** or the **LPA** during his tenure or for one (1) year thereafter shall have any financial interest, direct or indirect, in this Agreement or the proceeds thereof as identified in KRS 45A.340. The **Department** and the **LPA** shall comply with the requirements of the Executive Branch Code of Ethics KRS Chapter 11A. The **LPA** warrants that no person, elected official, selling agency or other organization has been employed or retained to solicit or secure this Agreement upon an agreement or understanding for a commission, percentage, brokerage, or contingent fee. No member, officer, or employee

of the **Department** or **LPA** shall collude or lobby on behalf of this **Project** without penalty, including but not limited to suspension or debarment.

20. To the extent permitted by law, the **LPA** shall indemnify and hold harmless the **Department** and all of its officers, agents, and employees from all suits, actions, or claims of any character arising from any injuries, payments or damages received or claimed by any person, persons, or property resulting from implementation of any phase of the **Project** or occurring on or near the **Project** site.

21. Either party may cancel the contract at any time for cause or may cancel without cause on 30 days written notice.

a. The **Department** reserves the right to cancel all reimbursements under this Agreement at any time deemed to be in the best interest of the **Department** by giving thirty (30) days written notice of such cancellation to the **LPA**. If reimbursement under this Agreement is canceled under this section by reason other than violation of this Agreement or any applicable law by the **LPA**, its agents, employees and contractors, the **Department** shall reimburse the **LPA** according to the terms hereof for all expenses incurred under this Agreement to the date of such cancellation of reimbursement.

b. The **LPA** may seek to cancel its obligations under this Agreement at any time deemed to be in the best interest of the **LPA** by giving thirty (30) days written notice of such request to the **Department**. If the **Department** agrees to allow the **LPA** to cancel the Project or cancel its obligations under this Agreement, the **LPA** shall reimburse the **Department** for all funding reimbursements made under this Agreement.

c. Any dispute concerning a question of fact in connection with the work not disposed of by Agreement between the **LPA** and the **Department** shall be referred to the Secretary of the Transportation Cabinet of the Commonwealth of Kentucky, or his duly authorized representative, whose decision shall be final. Any proposed change or extension to this Agreement shall be at the mutual consent of the **LPA** and the **Department** and be evidenced in writing.

22. The Kentucky General Assembly may allow for a reduction in a contract worker hours in conjunction with a budget balancing measure for some professional and non-professional service contracts. If under such authority the agency is required by Executive Order or otherwise to reduce contract hours, the contract will be reduced by the amount specified in that document.
23. The **Department** certifies that it is in compliance with the provisions of KRS 45A.695, "Access to contractor's books, documents, papers, records, or other evidence directly pertinent to the contract." The **LPA** hereby acknowledges it is responsible to inform any entity it intends to hire or use as a contractor, as defined in KRS 45A.030(9), that the contracting agency, the Finance and Administration Cabinet, the Auditor of Public Accounts, and the Legislative Research Commission, or their duly authorized representatives, shall have access to any books, documents, papers, records, or other evidence, which are directly pertinent to this contract for the purpose of financial audit or program review. Records and other prequalification information confidentially disclosed as part of the bid process shall not be deemed as directly pertinent to the contract and shall be exempt from disclosure as provided in KRS 61.878(1)(c). The contractor also recognizes that any books, documents, papers, records, or other evidence, received during a financial audit or program review shall be subject to the Kentucky Open Records Act, KRS 61.870 to 61.884.
24. KRS 45A.485 requires the **LPA** to certify that all contractors shall reveal to the **Department**, any final determination of a violation by the contractor within the previous five (5) year period of the provisions of KRS chapters 136, 139, 141, 337, 338, 341, and 342. These statutes relate to the state sales and use tax, corporate and utility tax, income tax, wages and hours laws, occupational safety and health laws, unemployment insurance laws, and workers compensation insurance laws, respectively.

The **LPA** shall certify that all contractors agree to be in continuous compliance with the provisions of those statutes which apply to the contractor's operations. Failure to reveal a final

determination or failure to comply with the above statutes for the duration of the contract shall be grounds for the **LPA's** cancellation of the contract and the contractor's disqualification from eligibility for future state contracts for a period of two (2) years.

25. It is understood and agreed by these parties that if any part of this contract is held by the courts to be illegal or in conflict with any law of the Commonwealth of Kentucky, the validity of the remaining portions or provisions shall not be affected, and the rights and obligations of the parties shall be construed and enforced as if the contract did not contain the particular part, term, or provision held to be invalid.


26. The **LPA** will pass a resolution authorizing the Judge/Executive to sign this Agreement on behalf of the **LPA**. An acceptable Resolution shall contain the project name, description, amount of funds being provided and an acknowledgement that the **LPA** agrees to ratify and adopt all statements, representations, warranties, covenants, and agreements contained in the Agreement. Furthermore, by accepting the funds the **LPA** agrees to all terms and conditions stated in the Agreement. A copy of that resolution shall be attached to and made a part of this Agreement.

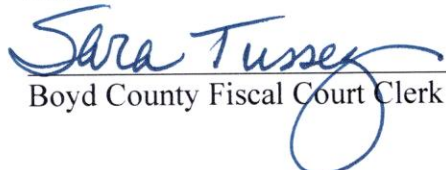
