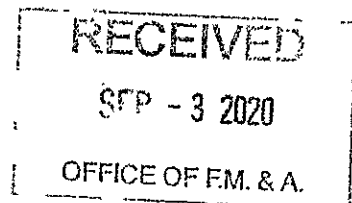

ORDINANCE NO. 2020-04

AN ORDINANCE RELATING TO COUNTY ADMINISTRATION OF A GLOBAL MONITORING SYSTEM PROGRAM AND SETTING AN ADMINISTRATIVE FEE PURSUANT TO KRS 67.372

Be it ordained by the fiscal court of the county of Boyd, Commonwealth of Kentucky:

Section 1 – Establishment

The Boyd County Fiscal Court hereby establishes a global positioning monitoring system program (GPMSP) as authorized by KRS 67.372.

Section 2 – Administration

The GPMSP is assigned to the Boyd County Detention Center (BCDC) and Jailer to operate and/or supervise the program continuously, twenty-four (24) hours per day, seven (7) days per week.

The BCDC, Jailer and Deputy Jailers shall assist petitioners, victims or witnesses in need of assistance when a person ordered to wear a monitoring device violates the provisions of a court order.

Section 3 – Contracting

Any entity with which the county contracts for providing the GPMSP and associated devices shall meet not less than all of the requirement of KRS 67.372 and KRS 403.761 and 456.100.

Section 4 – Contact Monitoring and Termination

The county shall monitor the performance or any entity providing the GPMSP system and devices and any contract shall require the entity to agree to termination of the contract in the event of serious or continued violations of the contract.

Any such contract shall also permit termination for convenience of either party upon _____ days written Notice to the other.

Section 5 – Compliance With Other Laws

Any GPMSP chosen shall comply strictly with the provisions of KRS 67.372(5)(a) and (b).

The provisions of KRS 67.372(6) are incorporated herein by reference and any contract for GPMSP services shall specify that no unit of state or local government and no public officer or employee shall be liable for costs associated with the contract or program except in strict compliance with KRS 67.372(6).

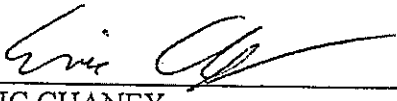
Section 6 – Administrative Fee

An administrative fee shall be charged to any person ordered to participate in the GPMSP to provide for the county’s cost in administering the program. This administrative fee is set at \$50.00 which shall be in addition to any fee or fees charged by the contracting entity and may be increased or decreased hereafter by amendment of this Ordinance.

Section 7 – Incorporation By Reference

KRS 67.372 is incorporated herein by reference as if set out in full. A copy of KRS 67.372 is attached hereto as “Exhibit A”.

This Ordinance be in full force and effect upon its adoption, readoption and publication according to law.
