LEASE AGREEMENT

WHEREAS, BCG LAND, LLC, a Kentucky limited liability company, of 991 Lancaster Street, Stanford, Kentucky 40484 ("BCG"), owns certain real estate in Boyd County, Kentucky, which the BOYD COUNTY FISCAL COURT, a governmental entity, of 2800 Louisa Street, Catlettsburg, Kentucky 41129 ("Boyd County"), wishes to lease and which is described elsewhere herein; and

WHEREAS, BCG wishes to cooperate with Boyd County and its citizens in any reasonable way possible in order to contribute to the improvement of the lives of the citizens of Boyd County;

NOW BE IT KNOWN AND AGREED as follows:

1. Lease/Premises. For and in consideration of the sum of One Dollar (\$1.00), cash in hand paid, the receipt of which is hereby acknowledged, BCG does hereby lease to Boyd County, under the terms and conditions set forth below, the following-described real estate:

2. Use of Premises. Boyd County may use the leased premises for any entertainment or entertainment-related activity so long as it does not violate any county ordinance or state or federal statute or regulation. However, the parties understand the intended main use of the premises by Boyd County is for live entertainment events.

3. Term. The term of this Lease shall be month-to-month, but shall be self-renewing each month unless a thirty (30) day notice of termination is given by one party to the other in the manner set forth in Paragraph 12 below.

Boyd County shall not schedule any event(s) after receiving notice of termination from BCG.

4. **Improvements.** Any improvements to the real estate of any type, either intended to be temporary or intended to be permanent, shall first be approved by a representative of BCG. All costs of improvements will be solely that of Boyd County.

5. **Removal of Improvements After Termination.** Any improvements made by Boyd County or any of its agents to the leased premises made during the term of this Lease, whether said improvements are intended to be temporary or intended to be permanent, shall be removed by Boyd County within thirty (30) days of the date of termination notice or the last event, whichever shall occur last.

However, at the sole discretion and direction of BCG, it may instruct Boyd County to leave in place any improvement made to the leased premises during the term of the Lease. All removal efforts required to satisfy this portion of the Lease Agreement shall be at the sole cost of Boyd County and shall receive final approval and release from BCG.

Boyd County shall also cause all trash, debris and any other miscellaneous items which have accumulated on the property to be removed.

Other than those improvements which BCG directs Boyd County to leave in place, Boyd County shall return the premises to the condition it was in at the time of commencement of the Lease Agreement insofar as same is reasonably possible.

8. **COVID-19.** Boyd County agrees to present any events it hosts in accordance with and in strict compliance with all recommendations of the Commonwealth of Kentucky and the Center for Disease Control regarding then in place public events of the nature to be hosted by Boyd County.

9. **Utility or Other Charges.** In the event there are utilities of any type installed by Boyd County or any other costs associated with the use of the land by Boyd County, those expenses shall be solely that of Boyd County, from which Boyd County will pay and hold BCG harmless from payment thereon.

10. **Recognition of BCG.** In consideration of BCG entering into this Lease Agreement with only a nominal Lease payment by Boyd County to BCG for use of the land, Boyd County agrees to recognize BCG Land, LLC on signage at any event, as well as recognition in press releases or other publicities for the events in a form and format presenting BCG Land, LLC favorably.




